Legislative; DeAnn

(Written report)

Robert DeLeo retired as Mass. Speaker of the House and was replaced by Rep. Ronald Mariano (D-Quincy.)

Mayor Marty Walsh was nominated to be U.S. Secretary of Labor and will likely be replaced by Kim Janey from Boston City Council, who will be the first black woman to serve as mayor of Boston.

Rep. Kay Khan was awarded the 2020 B.L.I.N.D. legislator award in a virtual ceremony.

D.C. Circuit Court of Appeals Chief Justice Merritt Garland has been nominated to serve as the next U.S. attorney general. Garland has a reputation for

being competent and moderate, though not an aggressive advocate for civil rights.

Vanita Gupta, who has a lot of civil rights experience, is nominated for associate attorney general, with Kristen Clarke, president of the National Lawyers' Committee for Civil Rights, heading the Justice

department's Civil Rights Division. Garland worked to improve transparency during his time on the appeals court. This is likely to be an improvement for disability rights.

DeAnn has reached out to ACB to learn more about the arrangements for the 2021 Washington leadership/legislative seminar meetings, imperatives, and what

impact this week's unrest in Washington may have. Given the COVID-19 pandemic, the inauguration and the unrest at the Capitol, it seems to be a fluid situation.

The U.S. Department of Transportation has issued new regulations that will impact service dogs and air travel. Specifically, service animals are limited to dogs, which brings the definition of a service animal into closer alignment with the definition in the Americans with Disabilities Act. Airlines can't

ban a particular breed and must allow psychiatric service animals to travel, although emotional support animals will not be permitted. The new rule permits

airlines to require paperwork for each round trip that may ask blind passengers to identify their dog's name, veterinarian, and other information. ACB welcomes the definition, but does not fully support the paperwork requirement, which many view as a step backward. ACB will continue to work with airlines

as they implement the regulations, which go into effect this Monday (January 11, 2021.)

The Worcester and New Bedford MCB regional offices closed on December 21st. An initiative is underway for consumers to direct letters to sec. Sudders

and Commissioner D'Arcangelo to halt the closings and maintain a physical presence in the community. Information can be found at:

The link to the 2020 voting survey was reposted in December, and the legislative committee will be working on the report soon.

DeAnn and Cheryl forwarded to President Charlson a draft response to the Online Accessibility Act, which deals with web accessibility. We're interested

in having a discussion about positions BSCB might take. The goal is to forward the response to Rep. Presley for consideration.

This year's final FY21 state budget included more than \$500,000 in earmarks for the Radio Reading program, including about \$300,000 for the Talking Information

Center. This was part of the Community Services line item in the MCB budget. Thoughts? (End of written report)

DeAnn said Cheryl has received 44 voter surveys so far, and they hope to receive a few more.

The closing of the Worcester and New Bedford MCB regional offices remains contentious. BSCB attendees learned at the most recent SAB meeting that there wasn't a formal consumer survey prior to the decision, and MCB hadn't made use of Newsline channels, which would be a way to reach individuals who do not use computers or social media and who are the majority of MCB consumers.

Brian assured the board it is a high priority to promote more effective communications from MCB officials.

DeAnn, who chairs the Rehabilitation Council at MCB, recently submitted the 2020 RC annual report to the RSA. Consumer concerns about transparency and the impact of closings were included.

The board briefly discussed the legislature's decision to provide \$550,000 in state funding to the Radio Reading program through the community services account of the MCB's budget. The program doesn't have a line item of its own and isn't subject to the same competitive public process to explore other

uses for the funding.
