The existence of Bay Lines Express presumably satisfies whatever constitutional requirement that might exist. Yet if it matters, I don't think I was ever formally approved by the Board as Bay Lines Express editor.

The legislative committee met on September 16 and will meet again on October 14. The committee is organizing a discussion on accessible voting for the fall BSCB conference to be held October 17.

Preparations are being made for accessible voting in the general election on November 3rd. ACB is organizing a call to give members a demonstration of VotingWorks, which is being used by six states, including Massachusetts. The Disability Law Center is continuing to support this effort with BSCB involvement.

October is Disability Employment Awareness month, as well as White Cane Day. BSCB member and ACB Students president Minh Ha will read the White Cane Law at the ceremony on October 16, which will be held by Zoom. October also marked the 10th anniversary of the CVAA.
